May 29, 2007

Call to Order

DeAnna Timmermann, Assembly Chair, called the meeting to order at 3:21 p.m. in Huber Auditorium.

Review of Meeting Minutes

It was moved that the May 1, 2007, Campus Assembly meeting minutes be approved as posted to the Assembly webpage: www.eou.edu/assembly; the motion was seconded. The minutes were approved.

President's Update

President Fatemi stated that in April of 2006 a presentation was given to the Board which was a three-year plan explaining where we stood and where we would like to be. That plan called for EOU to end last year with 6.4% fund balance and this year at 5.2% and then next year it would go up a little bit and the following year it would go up more. Last year was ended at 6.4% which was readjusted to 6.2%. This year we are at 5.2% or thereabouts which means we are still in the projected range. The budget has been being worked on over the past 11 months for the next biennium. Last July when budgets were submitted by the Board it included earmarks for regional universities as well as one for EOU. The Board's recommendation was 13 million dollars support for the regional universities. This would mean 3 million for each of the regionals and 1 million for the Cascade campus. The Governor cut the 13 million to 9 million and the rural action from 4.6 million to 1.6 million. The Co-chairs cut the 9 million to 2 million and rural action to zero. The Co-chairs then revised their budget and reinstated 7 million to make a total of 9 million dollars. It was understood that if there was extra money it would go to higher education. State economists released their projections and it went up by 152 million dollars. As soon as the number was published the promised amount vanished and all state agencies had to fight for their share. The Governor's revised budget reinstated 1.6 million and they are still working to get additional funding. State funding makes up approximately 49% of EOU's budget. The other 51% comes from tuition and fees. This year enrollment numbers have been very unusual. Fall enrollment was down 3.2%, winter down 5.0% and spring down 8.4%. This is a huge change and it is being investigated to determine why it happened and what impact it will have on our budget. Fall applications are also down significantly. President Fatemi went on to say that the core population in the 10 county regions is not going up much so enrollment increases will need to come from increasing high school graduates that go to college and by recruiting outside the 10 county regions as well as outside the state and county. He explained how other colleges have become aggressive and competitive in their recruitment efforts and that the competition is getting more serious and difficult. In the fall we will be looking at our budget with long range goals in mind. A short question and answer session followed.

Revised General Education

DeAnna Timmermann stated that the [Revised General Education](#) Proposal would be open to vote on from Wednesday at midnight to Friday at midnight.

Kathleen Dahl then showed the latest version of the general education proposal and explained that it was a top down charge from the OUS system to make general education requirements more compatible for students to transfer. She stated that the new proposal would streamline categories by narrowing them to 4 categories rather than 8 with an addition of 2 categories, some of which we have now and some which will be developed. She stated that all 60 general education credits can be completed within categories 1-4 or 15 of the credits can be completed within categories 5 & 6. Streamlined outcomes have also been developed to go along with streamlined categories.

An inquiry was made as to whether #6 Interdisciplinary should state “Multidisciplinary”. It was determined that it should, and the change was made to the document.

Donald Wolff then presented the [outcomes](#) and stated that the intention of the task force was to establish a broad and simple structure for general education. However, they do realize that there are some areas that will need refining and look forward to working on them next year.

MOTION: Approve basic general education structure and outcomes. Motion seconded.

DISCUSSION: A question and answer session followed including the following:

- An issue was brought up regarding general education courses and DDE not being able to fill general education requirements. It was explained that the

difficulty was recognized and that several artistic creation courses would be forthcoming.

- A concern was raised about where rhetoric courses would go. Response was that they will be housed in artistic creation or humanities. This particular issue has not been resolved yet. All current or existing general education will be plugged in somehow. It would be very helpful to hear from faculty in artistic creation and humanities. The voting would be on the general proposal rather than each particular general education course.
 - It was suggested that general education as an enrollment management strategy was problematic. The following were asked for consideration before voting:
 - Rather than have general education courses, which in some disciplines is all courses, level the playing field by having one upper and one lower division course in each discipline which would align better with the Oregon Transfer Model.
 - Mandate general education assessment so that we don't find out later that it does not work either.
 - Use student focus groups to see what students think about general education.
 - This could very possible lead us back to the same place we are now in 3 to 4 years from now.
 - Consider important resources which are our students before considering this proposal.
 - Implementation date was said to be Fall 2007.
 - There was some concern as to where some general education courses would go if they don't fit into any categories. The response was that they hope to meet with EPCC one more time and then come to Assembly via email. If this revision is not passed today it will not be put into place until Fall of 08.
 - Another concern was raised about losing language & culture programs and what recourse could be taken should this happen. It will depend on the structure that is in place next year.
 - Some discussion followed regarding language and speech and whether it would disadvantage our students.
 - Financial resources were another concern for the multidisciplinary inquiry category.
 - A suggestion was made to revamp the requirements for the BS requirement. By doing so it was thought that a difference would be made in language enrollment.
 - EPCC offered an amendment the current revised new general education policy which would pull the math prefix requirement out of general education and elevate* it to existing graduation requirements for both BA and BS students and it lower* the credits in category 2 to be consistent with the other categories.
- MOTION:** Moved for approval.
- DISCUSSION:** It was asked if the math requirement would not be a part of the general education courses but rather an additional requirement on top of the sixty. Colleen clarified that it could be folded in to be part of the general education and graduation requirements.
- It was suggested that the current BS degree, which requires a math course, include additional math and science components. This degree tends to be the one students fall back on due to less program requirements.

- There was additional discussion regarding math courses.
MOTION: Called the question on amendment to question 2 which takes math out of category 2. Moved for approval.
ACTION: Motion approved by Assembly members with 4 abstentions. Amendment will now be in proposal to go up for on-line voting.

[New Resolution to Restore the Tuition Plateau at EOU](#)

Greg Monahan explained that the people *to research the* financial implications of a tuition plateau should be the administrators. They would be in a position to determine what the plateau structure.

1. **Sex Matters** – Colleen Cascio pointed out the website for [Sex Matters](#) and passed* out bookmarks. She stated that they realized this was mostly from a woman's prospective and would appreciate male input.
2. **Task Force on Student Evaluations** – Donald Wolff recommended appointment of another committee to look at this. The current committee has a few recommendations but did not feel they were in a position to make some of the decisions. They suggested a DDE pilot study to get more students to participate in evaluations.
3. **Faculty Athletic Representative** – Reviewed academic policies regarding athletics and shared highlights & 2007-08 revisions.

4. **Rhetoric Conference:** Nancy Knowles informed people that EOU will be hosting this conference. It is currently in the call for proposals phase and she encourages people to participate. The Deadline is June 1st and the conference is October 5 & 6.
5. **Background Check** (Ad Hoc Committee) – DeAnna gave an update stating that the committee would be trying to bring their determinations to the Cabinet next year.
6. **Sexual Harassment and Consensual Relationships** (Ad Hoc Committee) – Marilyn* Ewing gave a policy review and mentioned that they were trying to determine whether it is user friendly, consistent with current EOU practice and in line with State and Federal laws. There will be a September 17, 2007 training for faculty.
7. **Tech Fee Committee** – Frederick Pratter gave an update which included that there will be a change in policy for submitting tech fee proposals. They will also be moving the date up to later in fall term to encourage student participation.
