FOURTEENTH AMENDMENT



Amendment XIV

Section 1. All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the state wherein they reside. No state shall make or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any state deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws.

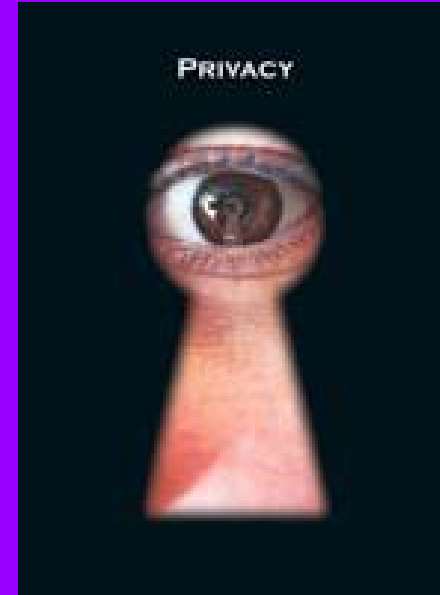


MAJORITY OPINION



- **Justice White**
- **No right to homosexual sodomy**
- **Never mentions privacy**
- **Western traditions**
- **Worries about new Due Process rights**

JUSTICE POWELL'S CONCURRENCE



- Justice Powell
- Worry about new Due Process rights
- Eighth Amendment
- 20 year prison sentence
- Hardwick was not convicted
- Powell's regret at retirement

JUSTICE BLACKMUN'S DISSENT



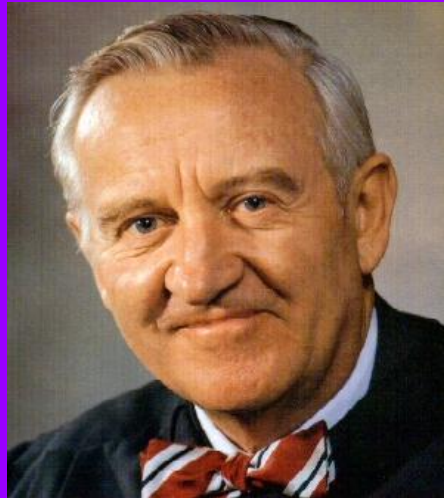
- **Justice Blackmun**
- **Case is about privacy**
- **Uses constitutional precedent**
- **Not impressed by the long held views**
- **Fundamentally important to a person**

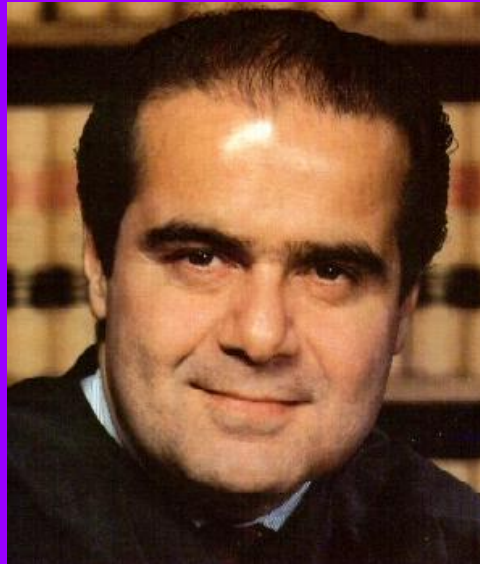
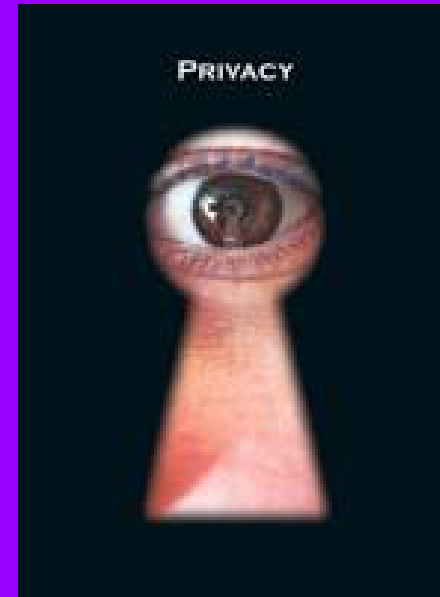

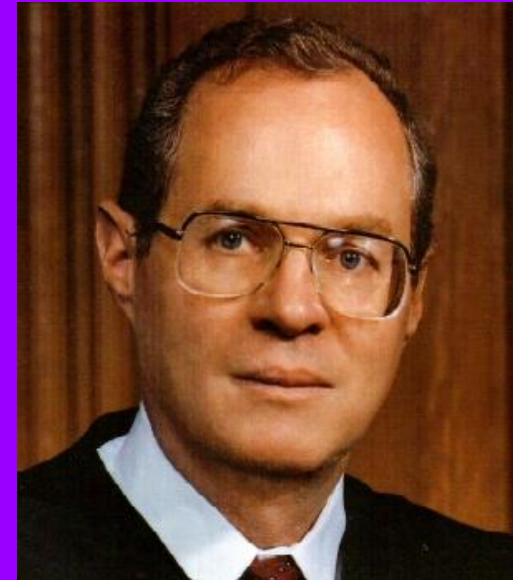

MAJORITY OPINION



- **Justice Kennedy**
- **Explicitly addresses and overturns *Bowers v. Hardwick***
- **No longstanding legal discrimination against homosexuals**
- **Due Process right to liberty and privacy in the home**

JUSTICE O'CONNOR'S CONCURRENCE



- Justice O'Connor
- Her ruling in *Bowers v. Hardwick*
- Agrees that the law is unconstitutional
- Fourteenth Amendment's Equal Protection Clause

JUSTICE SCALIA'S DISSENT



- Justice Scalia
- “I have nothing against homosexuals ...”
- *Stare decisis* and *Roe v. Wade*
- No right to homosexual sodomy
- Rational basis of the Texas law
- The “homosexual agenda”
