

CONSTITUTION OF E.O.S.C. ART CLUB

ARTICLE I NAME AND PURPOSE

The name of this organization shall be E.O.S.C. Art Club. As a non-profit student organization, we plan to provide the EOSC community and Union county residents with greater access to both visual and liberal artistic experiences; and to foster the growth and cultivation of the arts. We include ceramics, weaving, glass, metal and wood sculpture, metalsmithing, jewelry, painting, drawing, printmaking, photography, poetry, theater, dance, music and the sciences.

ARTICLE II QUALIFICATIONS FOR MEMBERSHIP

SECTION 1:

Membership in the EOSC Art Club shall be open to all students, faculty, staff and administration of Eastern Oregon State College.

ARTICLE III OFFICER AND MEMBER CATEGORIES

SECTION 1:

- Method of election and duration of office
- All positions will be filled at the end of Spring term to take office the following academic year for the period of one academic year.
 - Positions will be filled according to majority vote.
 - There shall be one president, one secretary and one treasurer.

SECTION 2:

Advisor(s) will be a member of the EOSC faculty chosen by the Art Club members. The advisor(s) will oversee the program of the EOSC Art Club and may act as arbitrator in matters of dispute at the discretion of the members.

ARTICLE IV
DUTIES OF MEMBERS

SECTION 1:

The president shall compile the agenda for each meeting. The president will give the agenda to the secretary for typing and the secretary shall post the agenda in a specified area one week in advance of the meeting.

Any member having a item for discussion must contact the president at least one week in advance of the next meeting.

The president will set the time allotments for each item of discussion.

Minutes of each meeting will be compiled by the secretary and posted within one week of the meeting's completion in the same location as the agenda.

A facilitator will be chosen at each meeting to chair the following meeting and will be given the agenda by the president and abide by the time limits set for each item of discussion.

The treasurer shall handle all moneys and provide financial reports at each meeting. The treasurer also must file a yearly financial report in June with the student activities office.

ARTICLE V
PARTICIPATION

SECTION 1: A member in standing is one who has paid dues.

You must be a member in standing in order to participate in sales or any function requiring travel.

10% of each students sales returns to the EOSC Art Club.

51% of the members present at a meeting constitutes a majority vote. Written votes may be submitted to the president during the week before the meeting.

Any member may participate in a sale upon approval by a selected board of jurors. The jury will be composed of one faculty advisor and three students with major areas of interest in two dimensional work, three dimensional work and crafts.

Dues will be \$3.00 annually
