

CONSTITUTION OF THE AMERICAN CHEMICAL SOCIETY

ARTICLE I-NAME OF THE ORGANIZATION

SECTION 1: The name of this organization shall be the Eastern Oregon State College Chapter of Student Affiliates of the American Chemical Society.

ARTICLE II-PURPOSES OF THE ORGANIZATION

SECTION 1: The purposes of this chapter shall be to afford an opportunity for the students of chemistry, chemical engineering, or related disciplines in science to become better acquainted, to secure the intellectual stimulation that arises from professional association, to secure experience in preparing and presenting technical material before chemical audiences, to foster a professional spirit among the members, and to instill a professional pride in chemistry and chemical engineering.

ARTICLE III-MEMBERSHIP

SECTION 1: The membership of this chapter shall be composed of Student Affiliates of the American Chemical Society and Associate Members of the American Chemical Society.

ARTICLE IV-OFFICERS OF THE ORGANIZATION

SECTION 1: The officers of this chapter shall be a chairman, a Vice Chairman and a Secretary-Treasurer, who shall constitute the Executive Committee.

SECTION 2: The officers shall be elected at the regular meeting in May from nominees chosen by the nominating committee and nominations from the floor. They shall take office on June 1 after the May elections and shall hold office for one year or until their successors are duly elected.

ARTICLE V-DUTIES OF OFFICERS

SECTION 1: *The duties of officers, namely, Chairman, Vice-Chairman and Secretary-Treasurer shall be such as usually pertain to the offices they hold*

ARTICLE VI-FACULTY SPONSOR

SECTION 1: *The chapter at its annual election shall elect as its Faculty Sponsor a faculty member who is a member of the American Chemical Society, whose duties shall be to advise the chapter both in its local activities and in its relations with the Society. He shall be kept informed of all chapter activities and his advice shall be sought on all matters of policy.*

ARTICLE VII-PROFESSIONAL ADVISOR

SECTION 1: *The chapter at its annual election may select as its Professional Advisor a non-faculty Member of the American Chemical Society. His duties shall be to assist the chapter in liaison with the local ACS section and with organizations employing chemists.*

ARTICLES IIX-MEETINGS

SECTION 1: *Regular meetings shall be held on the second Wednesday of each month during the regular academic year and others on call. Special events may be arranged through the Executive Committee and publicized through notices posted on the bulletin board located near room 209 Badgley Hall. There shall be at least four special activities per year.*

SECTION 2: *Students who are not members of the chapter may help plan and participate in the activities of the chapter, at the discretion of the Executive Committee.*

ARTICLE IX-DUES

- SECTION 1: *The annual national dues of Student Affiliates shall be sent individually to the Society or may be transmitted by the Secretary-Treasurer of the chapter.*
- SECTION 2: *Local dues of \$2.00 annually shall be collected by the Treasurer of the chapter. Membership in the chapter is limited to those who have paid local dues.*

ARTICLE X-ANNUAL REPORTS

- SECTION 1: *The chapter shall submit to the Executive Secretary of the Society an annual report of its activities. This report, which shall be submitted on the appropriate form, shall include a statement of the meetings held during the year, dates of each, attendance, speakers, and subjects; and a list of officers and the number of Affiliates and Associate Members, on the Chapter roll. The Executive Secretary of the Society shall be informed promptly on the results of all elections of officers.*

ARTICLE XII-AMENDMENTS

- SECTION 1: *These Bylaws may be amended by a two-thirds vote of the members, provided that the amendment shall have been proposed at least one meeting previous to the time of voting. Such amendments shall conform to the regulations established for Chapters of Student Affiliates.*
