
## **Meeting Summary:**

## **Project Background**

Citizens of Wallowa and Union Counties approached the Wallowa Union Railroad Authority (WURA) and asked about the feasibility of a rail-trail on rail right-of-way from Elgin to Joseph. WURA approached local, regional and state partners about developing a partnership to review the feasibility and suitability of a rail-trail. The planning team has developed a scope of work and process to help determine the following in a concept plan:

- The level of local community support for the rail-with-trail concept;
- Physical and environmental conditions within the rail corridor and how a trail could be accommodated within and/or adjacent to the existing right-of-way;
- Impacts that the trail could have on existing and future uses within and adjacent to the rail corridor;
- Opportunities that the trail could provide for local and regional recreation;
- Opportunities that the trail could provide for tourism and economic development;
- Opportunities for integrated education and community learning led by a major Oregon University partner;
- Whether the trail could be designed and managed to address concerns identified by WURA, local communities, landowners, and agencies; and
- Options for funding the cost of development and of ongoing maintenance of the trail.

The planning process will follow three phases: Assessments, Concepts and Report.



**Review of Existing Conditions Report** 

The planning is currently in the assessment phase. There was an overview of the assessments being conducted, such as:

- Stakeholder Input
- Economic Impact Assessment
- Adjacent Land use Assessment
- Historic Assets Assessment
- Existing Recreation and Tourism Asset Assessment
- Physical Assets Assessment
- Physical Environment Assessment

## **Public Comments:**

E.M. "If funding is a challenge, this project could be done incrementally, a few miles at a time. I really like the idea of accessing the trail from Palmer junction, thus dividing what might be conflicting users, e.g. hikers and horses, or baby strollers and roller bladers."

M.M. "How did WURA get control of this investment without community involvement? Plus

demographics favoring those adjacent and [in] close proximity to corridor skews towards negative. Should be focusing on younger people who do not live in a rural setting. Corridor should support healthy lifestyles. Emphasize parents etc."

- L.L. "I live in town (Elgin) right above the railroad tracks. My concern would be any cutting into the hill below our house to accommodate the path. There are approx. 6 houses along that Beginning stretch from Eglin that would be affected by this. Also Summer (dry) season what about the potential of someone smoking, throwing out their cigarette and starting a fire??"
- M.H. "This is a very well thought out and positive project for NE Oregon."
- K.R. "Being that 70% of chronic diseases (high blood pressure, diabetes, cardiovascular disease) can be treated, prevented and reversed with good lifestyle choices and exercise, having a quality trail for walking an riding bikes (getting exercise) would be welcomed by the medical community and hospital administration! To encourage the development of a healthy community, it's critical to provide adequate facilities to encourage heathy lifestyle choices, specifically a safe and quality way of getting exercise."
